4.1. New Parish Councillor.

4.2. Winter Gritting.

Mrs Warhurst reported that we had been awarded a grant of £250 from Rural Action Yorkshire to help with Winter Preparations.

Mr Henderson has now purchased and stored the grit and has sent a bill to the Parish council.

4.3. Grass Cutting Tender.

Mr Wigin is waiting for three quotations. This will be discussed at the next meeting.

4.4. Affordable Housing.

Mr Hugill is waiting to hear from Mr G Chapman about one of the possible sites. Amanda is waiting for responses from landowners. A general discussion was held this evening with those villagers present, about the need for some Affordable Housing and the benefits of drawing up a Neighbourhood Plan to promote a mixed housing development which might include affordable houses. A question was asked about the rental costs for Affordable Housing. Amanda Madden would be asked to give this information. Mr G Hunter offered to invite a representative from another Parish Council to come along to a future meeting and tell us more about their experience of drawing up a Neighbourhood plan.

5. Matters Arising this Meeting

5.1. Stile.

The stile at the bottom of the footpath leading to the A19 would be visited by Andy Brown from NYCC with the intention of fitting a dog latch. Lady Bell and Sir John had no objections. A dog latch had been promised in the past on Green Lane near Fowgill Farm. We would ask for this to be installed as well.

5.2. Neighbourhood Watch.
