1. Apologies

2. Minutes of 16 September meeting

3. School Playing Field

CW reported that discussion was ongoing between Beyond Housing and NYCC.

4. School Site

- CW reported that Beyond and the Diocese had exchanged Heads of Terms and negotiations were ongoing.
- CW reported that a site meeting had been held by HDC Planning Committee (morning of 14 Oct) to review the Outline Planning Application. CW was given the opportunity to put forward the Parish's opinions. The Planning Committee formally meet on 17 October to make a formal decision. Kathryn Jukes of Directions Planning will make a presentation on behalf of the PC.

5. Beyond Housing

6. Grain Store

- A meeting with Chris France, Director of Planning, NYMNPA, had been held. Mr France stated that under both the existing and emerging new local NYMNPA plan only affordable housing could be built on the Grain Store site. The only exception to that position would be if the site was accepted by both the NYMNPA and the landowner as an "Environmental Enhancement Site" (Policy ENV15). This would allow the site's redevelopment on a planning brief as agreed between NYMNPA and the landowner. Mr France went on to state that there would then be far more flexibility to have a range of housing types not solely affordable housing. Mr France said that putting that classification case forward in the next draft Plan would be the appropriate course of action.
- It was agreed that the option would be discussed with the landowner and, if agreed, incorporated into the Plan's next draft.

Action:

DC to arrange a meeting with the landowner to discuss.
